FACULTY ACCOMPLISHMENTS

DANIEL BARNHIZER

Professor Barnhizer was awarded the Man of the Year award in June by the Vytautas Magnus University Law Faculty of Kaunas, Lithuania. This is given annually to "the person who most clearly embodies the ideals of both the Faculty of Law and the University." Barnhizer and his co-authors James J. White, Robert S. Summers, Wayne Barnes, and Franklin G. Snyder, published *Principles of Sales Law*.

Professor Bean presented "What Lessons from the Transformation of the Russian Economy in the 1990s Are There for Cuba?" at the American Bar Association's International Law Section.
