CONFERENCE: Indigenous Law Conference

MSU Law's Indigenous Law and Policy Center and the Tribal In-House Counsel Association co-hosted their 15th annual Indigenous Law Conference. Professor Matthew Fletcher, of the Grand Traverse Band of Ottawa and Chippewa Indians, provided the keynote address. The three day program featured eight panel discussions covering topics from litigating difficult ICWA cases to tribal self-regulation of healthcare.

Panel discussants included representatives of the Cherokee Nation of Oklahoma, Chickasaw Nation, Choctaw Nation of Oklahoma, Gila River Indian Community, Pokagon Band of Potawatomi Indians, Pueblo of Nambe, Navajo Nation, the Swinomish Tribal Community, Ute Indian Tribe, Muscogee (Creek) Nation, White Earth Nation, Poarch Band of Creek Indians, Crow (Apsáalooke) Nation, Nez Perce, and The Confederated Tribes of Grand Ronde.
